



**Chulalongkorn University Announcement on Admission to
Bachelor of Arts and Science in Integrated Innovation (International Program)
Chulalongkorn School of Integrated Innovation
Academic Year 2025 (Admission Round)**

Chulalongkorn University is now accepting qualified applicants for **Admission Round** to the Bachelor of Arts and Science in Integrated Innovation (International Program) for the Academic Year 2025. The application process is as follows.

1. Qualifications and Requirements

1.1 Applicants must have completed high school **or** are currently in the final year of high school (Matayom 6 in Thai system, Grade 12 in the US system, or Year 13 in the British/IB system) **or** passed an equivalent high school standardized test.

1.2 Applicants must submit all documents of the 2 following standardized tests:

1.2.1 Applicants must achieve at least the minimum score of any of the following English proficiency tests. Applicants may submit more than one English proficiency test score

- TOEFL (Internet-based) not lower than 80 **or**
- IELTS not lower than 6.5 **or**
- SAT (Evidence-Based Reading and Writing) not lower than 500 **or**
- ACT (English & Reading) not lower than 37 **or**
- CU-TEP not lower than 100

(Chulalongkorn University Test of English Proficiency)

1.2.2 Applicants must achieve at least the minimum score of any of the following Mathematics proficiency tests. Applicants may submit more than one Mathematics proficiency test score.

- SAT (Mathematics) not lower than 640 or
- ACT (Math) not lower than 27 or
- CU-AAT (Math Section) not lower than 620

If an applicant chooses to submit the scores from both sections of SAT (Evidence-Based Reading & Writing and Math) or ACT (American College Testing Assessment – English, Reading and Math), the scores must be from the same test (i.e. taken on the same day).

For applicants who do not meet the criteria outlined in items 1.2.1 or 1.2.2 (1 of the 2 items), they must achieve at least the minimum score on one of the following composite scores from the specified tests to be considered and have their eligibility decided based on the criteria stated in Section 5.

Applicants must achieve at least the minimum score of any of the composite scores.

- SAT Composite Score ไม่ต่ำกว่า 1300 หรือ
- Overall GED Score ไม่ต่ำกว่า 700

All scores pertaining to sections 1.2.1, 1.2.2, and 1) must not be older than two years on the application deadline.

1.3 Applicants must submit an E-Portfolio which consists of a collection of the applicants' work as well as activities. An **E-Portfolio** must be created and submitted via the CSII Admission Platform (<https://www.csiiadmission.com>) only.

1.4 Applicants must demonstrate good behavior and commitment to study to the best of their ability and agree to fully comply with all current and future university regulations.

If it is later found that the applicant lacks the required qualifications, has provided false information, or submitted false or forged documents, the school reserves the right to revoke their right to participate in the selection process, even if they have applied or been selected. Furthermore, the applicant may be subjected to legal prosecution.

2. Admission Seat

Chulalongkorn University will admit 15 qualified students to the Bachelor of Arts and Science in Integrated Innovation (International Program) for the Admission Round of the Academic Year 2025

4. Application Process and Documents

4.1 Application Process

4.1.1 Applicants must complete all required sections in the CSII Admission Platform (<https://www.csiiadmission.com>) during the Application Period.

4.1.2 Applicants must ensure the accuracy of all information provided. Once the application is submitted, no further edits will be allowed.

4.1.3 Applicants must pay the application fee of 1,500 Baht (one thousand five hundred Baht only) at Kasikorn Bank, Account Number 168-8-09277-5, Account Name: Chulalongkorn University Integrated Innovation Institute, MBK Center Branch. Then, scan the proof of payment and upload the document via the CSII Admission platform at website <https://www.csiiadmission.com>.

4.1.4 Applicants must scan the supporting documents as outlined in section 4.2, ensuring that all copies are signed and certified as true copies. Arrange the documents in the correct order, save them as a .pdf file, and upload the file via the CSII Admission Platform at <https://www.csiiadmission.com>.

Applicants are responsible for ensuring that they meet the qualifications outlined in the admission announcement and for providing accurate and truthful information in their application. If any errors occur due to the applicant, or if the uploaded documents are found to be inconsistent with or not in accordance with the admission requirements, the applicant will be deemed ineligible for the selection process from the start.

4.2 Application Document

4.2.1 Applicants must complete all required sections in the CSII Admission Platform (<https://www.csiiadmission.com>) and must ensure the correctness of all the information given.

4.2.2 A student photo in .jpg format with a maximum of 10 MB file size. (A full-face photo with a white or blue background, not wearing a hat or sunglasses, in formal attire, taken within the last 6 months.)

4.2.3 A copy of High School Completion, a certified copy of diploma certificate from the high school and academic transcript(s)

In case applicant is currently in the final year of high school, a copy of official document certifying academic status from the applicant's school is required.

If the applicant has graduated from an institution abroad or holds an equivalent qualification, they must attach a copy of the high school equivalency certificate or a provisional equivalency certificate. For more information, please visit <https://hscs.atc.chula.ac.th/>

4.2.4 Test results from 1.2.1 and 1.2.2 and/or 1) (if any)

4.2.5 E-Portfolio from 1.3

4.2.6 A certified copy of Thai national ID or passport

4.2.7 Name change official document (in case applicant has a different name in application documents)

4.2.8 Upload money transfer slip via CSII Admission Platform with the present of applicant's full name.

Applicants must submit all required supporting documents; otherwise, the Integrated Innovation Institute will not consider the application under any circumstances.

When the application is submitted, it implies that the applicant has already verified the requirements. No refunds will be made after the application has been submitted.

5. Evaluation Criteria

Eligible applicants will be evaluated on the proficiency test scores, aptitude test, E-portfolio and interview, and Team Spirit Assessment. The following weighting will be assigned as follows:

6. Enrollment Criteria

6.1 Eligible candidates for admission and registration as students in Chulalongkorn University must have successfully completed upper secondary education (Matthayom 6) or an equivalent program. If the university later finds that a candidate has not completed the required education or does not meet the specified qualifications, their eligibility for admission will be considered void. The university reserves the right not to refund the application fee, enrollment confirmation fee, and tuition fees in any case.

For those who have completed their education through the high school equivalency or graduated from a foreign school not recognized by the Ministry of Education, their qualifications must be certified according to the criteria set by the Council of University Presidents of Thailand (CUPT) regarding equivalency of upper secondary education for university admissions. 6.2 Eligible candidates who have already registered as students at Chulalongkorn University and are later found to have submitted false or forged documents during the application, selection, or registration process will have their admission revoked and may also face legal action.

6.3 If Chulalongkorn University finds that an eligible candidate has confirmed their admission to more than one program, their admission rights to Chulalongkorn University will be revoked without prior notice.

7. Scholarship

The applicants are eligible to apply for the scholarships as announced by Chulalongkorn School of Integrated Innovation, during the application process.



8. Tuition Fee

University fees and program tuition fees are charged in accordance with the Announcement of Chulalongkorn University.
